Payment and Registration: By signing and returning the registration form included, you are agreeing to pay all fees listed at the **time of registration**. Sharing of Exhibit Space is not allowed unless approval is requested and approved by Central Valley Con. Any requests of this nature must be made at the time of registration. **You must be paid in full by February 15th or your registration may be cancelled.**

California Seller's Permit: As noted on the registration form, a valid **California Seller's Permit Number** is required to sell any merchandise at your exhibition space.
